INTRODUCTION

PURPOSES AND LEGAL BASES FOR DATA PROCESSING

Your data may be processed for the following purposes:

i. Management of business relationship with potential customers:

Legal basis: performance of pre-contractual measures.

ii. Marketing and commercial communications:

- a) Sending promotional communications, newsletters, event invitations, and information about the Group's Companies' products/services by using automated means (email/SMS).
Legal basis: Data Subject's consent.
- b) Sending promotional communications, newsletters, event invitations, and information about the Group Companies' products/services using non-automated means (mail, operator phone calls).
Legal basis: legitimate interest of the Data Controller.
- c) Managing information requests received via forms or other contact points provided.
Legal basis: legitimate interest of the Data Controller.
- d) Sending customized promotional communications, newsletters, event invitations about the Group's Companies' products/services by using automated means (email/SMS), based on Data Subjects' preferences.
Legal basis: Data Subject's consent.

NATURE OF DATA PROVISION

The provision of your personal data is optional. However, a refusal to provide such data may prevent the Joint Controllers from properly managing your business-related requests.

DATA PROCESSING METHODS

In processing your personal data, the Joint Controllers adopt appropriate technical and organizational measures proportionate to the risk, in compliance with Article 32 of EU Regulation 2016/679.

DATA PROCESSOR

Your personal data may also be processed by third-party companies acting as Data Processors, pursuant to Article 28 of the Regulation, who carry out data processing activities on behalf of the Controllers, where such activities entail data processing.

DATA RETENTION PERIOD

In compliance with the principles of lawfulness, purpose limitation, and data minimization (Article 5 GDPR), your data will be retained as long as necessary to fulfill the relevant purposes.

In particular, your data will not be stored for more than:

- 5 years from the last contact or useful interaction.

Consent will be retained:
